SUMMARY ANNUAL REPORT

FOR ROOFERS LOCAL NO. 74 ANNUITY FUND

This is a summary of the annual report for the Roofers Local No. 74 Annuity Fund, EIN 45-2840767, Plan No. 001, for the period June 1, 2015 through May 31, 2016. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$117,019. These expenses included \$84,309 in benefits paid to participants and beneficiaries and \$32,710 in administrative expenses. A total of 263 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$2,170,619 as of May 31, 2016, compared to \$1,501,328 as of June 1, 2015. During the year the plan experienced an increase in net assets of \$669,291. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's net assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$786,310, including employer contributions of \$827,104 and net earnings (loss) from investments of (\$40,894), and miscellaneous income of \$100.

- 1) An accountant's report;
- 2) Financial information and information on payments to service providers;
- 3) Assets held for investment;
- 4) Transactions in excess of 5% of Plan assets.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report.

You also have the legally protected right to examine the annual report at the main office of the plan (Roofers Local No. 74 Annuity Fund, 2800 Clinton Street, West Seneca, New York 14224) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
